A. Call to order 7:30PM: Additions to the Agenda: none

- **B. Adoption of the minutes from QCB AGM meeting**: February 23<sup>rd</sup>, 2011 **MSC: YES** with changes
- **C. Train Report**: Brian: Documents have been filed bye the RR with appeals court. Same argument as before that there is a agreement in place. RR says we have not said that agreement has not been upheld and we are just not happy. Court docket full for this year so will probably not make it to the courts until 2012.

We have had other communities contact us regarding this as they have similar issues in other communities.

- D. Business Arising from the minutes:
  - 1. Plaza 88 and McInnis overpass: NTR
- **2. Strata Council List Update:** Reminder to advise any changes as a result of AGM elections.
  - 3. Poplar Landing Development: NTR
- **E. President's Report:** James: Has been attended the United Blvd Extension consultation meetings discussion was provided, concerns raised about if the community is being moved into a decision they don't want. Report on the 150 Celebration Cost close to \$1Million was spent in dollars and in kind value. The Japan Fundraising event was well attended and raised around \$10,000. A discussion around school board lunch policy for children and relevance to the QCB was provided. With the building of a school on the St Mary's site the QCB will likely have kids attending from our community. City has approved a property tax rate at 2.98% Electrical rate increase 8%. Represented 28 Strata owners at a recent appeal and was successful in a reduction and it was noted that other units at the Quay may have received a reduction as a result of questions raised by the appeal. Some owners had increased assessments of over 52%. This will have a major impact on property taxes. Some owners over the age of 55 may have property taxes deferred and should consult with the provincial gov't website.
- **F. Treasurer's report:** Maureen: Only 2 outstanding memberships dues outstanding Bal: \$5305.60

## G. Regular Business:

- **1. Westminster Pier Park:** James: More questions then answers regarding park remediation and additional costs. There will be no access to the park at 6<sup>th</sup> St over the rail tracks. Only limited access to this park and only a partial park from original plans. Access will likely be from the Larco property only. Waiting to hear about the art in the park and cost to install.
- **2. Civic (Convention) Centre**: City Representative: This has gone to Design panel on Tuesday May 3<sup>rd</sup>, staff has been asked to make some improvements.
- **3. Quayside Board boundaries**: James: Interesting development we have been approached by the Downtown Residents Association to coordinate or combine efforts to make the community a better place and advocate and support each group. Board approved a meeting with the both executives to see what they have in mind and how this may evolve over time. James to attend the DRA meeting on June 1<sup>st</sup>.
- **4. Vehicle speed on Quayside Drive Petition**: Harvey: has stepped down we have now combined this with #2 under committee reports Traffic, buses, that Michail reports on.

Tiffany Shores: NIA Tower I: Block watch program participants Looking to put in a bylaw to have fireplaces cleaned every two years. Tower II: Power washing outside of building and annual window cleaning in process. Just finished dryer duct annual cleaning. Murano: replaced caretaker and will be washing exterior of building. Westport: Painting outside of building, hired new custodian and break-ins have happened in secured areas. Westminster Landing: Putting on a new tiled roof replacing metal, taking part in a recycling program for bikes. The Q: NIA

### Possible updates to pages on the site:

Home page - reduce content now on the page. Make it more relevant to present issues by:

- eliminating dated items. Instead create archive pages as needed.
- focusing on items of current interest eg. Plaza 88, Rail Noise, River Market while providing links to specific archived historic information.

**Quayside Community Association - formed Jan 1996** 

Quayside Community Board - formed Sept 2004 not on website

- ensure all links are working presently all links from 2008 and earlier cannot be accessed
- create complete archive file of QCB minutes 1996+.
- If printed files obtained, I can copy and provide .pdf versions for the website

**Blogs** – e.g. dogs, rail issues. Encourage resident participation.

**Users of the website** - James noted that many are potential property buyers. This has implications re

keeping pictures and news current.
