- **4. Surrey Port and Coal Transfer:** James: Information continues to flow from the USA export of thermal (dirty) coal opposition. Members are reminded to remain vigilant and to respond to any requests for letters and emails to elected officials, Metro Vancouver and Port Metro Van.
- **5. Bylaws**: Dorothy: presented a review of the bylaws for consideration and requested that members bring suggestions by April 30th. Once received by the board the bylaws will be sent to each strata council President for consideration and review by strata corporations.
- **F. President's Report:** Penny: Reviewed the information for Timber Park eastern part of Pier Park. Went to the Larco presentation of towers one being 45 stories. Questions asked about why the city was presenting the development. Since they are negotiating new zoning the city is doing the work to promote this proposal. Members are encouraged to write letters about concerns. There are community grants available for various projects.

H. Regular Business

1. Westminster Pier Park: Lynn: city looking at the eastern portion call Timber Park and what to do with the area. The pedestrian overpass is coming along scheduled for fall opening.

- **2. Civic (Convention) Centre:** Lynn: going well September opening and open house being scheduled details will be released and asked members to check out the face book page to join.
- **3. Pedestrian Overpass to Queensborough:** Lynn: the city prefers Option 1 a separate bridge. However unless there is 3rd party funding it will be difficult. Option 2 is tied to the rail bridge and is the one city can afford at this time. Looking for more funding to build Option 1.
- **4. Festivals:** James: Hyack Festival Canada day fireworks at the Quay. Hyack looking for volunteers who know the Quay. Potential for sponsorship but directors did not pass a motion to consider. The QCB Festival in August 16th this year and food trucks are registering with our house band Legal Limit confirmed. Space and table request are coming in and we may have a mascot parade as there are a number of them available. Volunteers are requested to help this year and will get moving in June.

- 1. Traffic, Buses, Gateway and Boardwalk: Michail: last meeting problems were discussed concerning McInnis Bridge as it relates to the Larco and Bosa developments. City is unable to provide advice on the process. Larco development is presenting no problems. Royal Ave and Pattullo Bridge discussed but the report was not discussed.
