- A. CALL TO ORDER 7:30PM
- B. ADOPTION OF THE MINUTES FROM QCB MEETING: October 28th, 2009 MSC:
- C. BUSINESS ARISING FROM THE MINUTES:
- 1. Plaza 88 report: Allan: No news out from Plaza 88. Crane is now gone. No activity on the commercial units. Columbia street frontage has yet to be determined. Commercial development still pending approval. Concern raised about exit from parkade and request for stop sign. Also a lot of confusion over the cross walks there are too many and they are not clearly defined. Asked our city representative to review with city staff and advise.
- 2. Website: Reminded everyone to visit often. Invoice from STC for \$52.50 Motion to approve MSC: YES
- **3. Mailbox for west end of Quayside Drive:** Matthew: Good news there has been an email received with preliminary approval maybe for spring next year.
- 4. Strata Council List Update: Please advise any changes at your strata council. Will send out sheet.
- 5. Poplar Landing Development: Allan: NTR
- **6. Urban Sustainability:** Matthew: Handed out stickers for garbage bins. Winter market is to start Dec 12 from 10AM to 2PM Holy Trinity Cathedral on Carnarvan St. and continue thru next year. Poster will be sent. City approved 4 community gardens for 2011. It was suggested the Muni Park area might be a good choice.
- 7. Off Leash Dogs: Ted: NTR. However the off leash dog park is still very wet after rainfalls.
- **C. PRESIDENTS REPORT:** James: Attended the final workshop on the downtown plan. Was told the property at 801 Columbia beside old Salvation Army store was for a heritage walkway/square. Final report going to council for approval. Attended the Pier workshop. Priority on 12 items for the park. Working on the Hyack Christmas Parade of Lights for Dec 5<sup>th</sup> at 4PM. Hyack Square will have lots of things to do after the parade. Tree lighting, entertainment, hot chocolate and don't forget Mr. & Mrs. Santa Clause will be there. Want to thank Anchor Pointe for allowing us to meet here all year long and to continue to provide this meeting room in 2010. I also attended city council on Nov 9<sup>th</sup> regarding save the Massey Theatre. Over 200 people were at the meeting and city council put forward a motion to get together with the School Board. If anyone has a copy of this meeting taped from TV please contact me as soon as possible. Should note that the city will not take up to 30 years to complete the Pier Park as reported in the NewsLeader Nov 22<sup>nd</sup>. Sale of the expropriated land on the north west corner of Columbia and 8<sup>th</sup> Street being put forth. Burr Theatre has been short-listed and the Columbia Theatre group has not been successful in its bid at this time the offer did not make the short list. No further announcement has been made. Would like to thank the board for all the input hard work and attending the meetings over the last year. Happy Holidays!

Since James will not be standing for election next year he will chair the nomination committee if agreed. Check to see if the Discovery Center is available and book if possible. This will help promote an important visitors place at the Quay.
- **3. Massey Theatre:** Members were asked to keep informed and write letters of support to council asking to keep Massey Theatre as an important part of New Westminster's community and heritage. Watch for announcements.

5. Holiday Homes Tour: QCB asked to sponsor the first annual Holiday Tour by the group of 5 to raise money for Columbia Hospital. No cost to the QCB but poster distributed to our members.
